

BYLAW NO. 37-86

A BYLAW TO ESTABLISH A PLAN FOR THE CO-ORDINATION OF MUNICIPAL SERVICES IN THE EVENT OF DROUGHT, BLIZZARDS OR MASSIVE SNOW STORMS, FREEZING ICE STORMS, MAJOR WATERMAIN BREAK, METEORITE FALL, PIPELINE EXPLOSION, POWER BLACKOUT, SUDDEN WASTE DISPOSAL PROBLEMS, RADIATION FALLOUT, CHEMICAL CONTAMINATION OR SPILL, MASSIVE AUTOMOBILE ACCIDENT, AIRCRAFT CRASH, DUST OR SAND STORMS, TORNADO, WATER POLLUTION, TRAIN DERAILMENT, TOXIC/FLAMMABLE GAS ESCAPE, BUILDING OR STRUCTURE COLLAPSE AND UNCONTROLLABLE FIRE OR THE THREAT OF ANY OF THE FOREGOING.



The council of the Rural Municipality of Moose Creek No. 33, in the Province of Saskatchewan, enacts as follows:

1. The establishment of a local Emergency Measures Organization which shall consist of two branches known as;
 - (a) The Executive Committee, and
 - (b) The Planning Committee.


The Executive Committee shall have authority to;

- (a) Establish policy for the Rural Municipality of Moose Creek No. 33 Emergency Measures Organization, and
 - (b) Appoint an Emergency Measures Co-ordinator and such other persons as may be required to assist the Emergency Measures Co-ordinator.
2. The Emergency Measures Co-ordinator shall be the Chairperson of the Planning Committee.
 3. The Planning Committee shall consist of Officers of the Rural Municipality of Moose Creek No. 33 and such other persons holding public and private office as deemed necessary and appropriate.
 4. To provide funding as deemed necessary and appropriate in the establishment and maintenance of the Local Emergency Measures Organization.

MEMORANDUM OF AGREEMENT made this 12th day of August, 1986 A.D.

BETWEEN: (a) The Town of Oxbow
(b) The Town of Alameda
(c) The Village of Glen Ewen
(d) The Rural Municipality of Enniskillen No. 3
(e) The Rural Municipality of Moose Creek No. 33

THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. That the parties to this agreement form a Mutual Aid Area.
2. That each party to the agreement will assist any other party to the agreement in the event of a disaster.
3. That the Town of Oxbow be recognized as the Emergency Response Centre.
4. That the objectives of the Mutual Aid Area are as follows:
 - (a) To provide a unified, effective organization involving neighbouring communities to lend reciprocal assistance, expertise, and equipment in a declared disaster or
 - (b) To provide an effective program of communications involving modern equipment and training in the event of a disaster.
 - (c) To meet and prepare an up-to-date list of available resources in each community inclusive of equipment and manpower services.
 - (d) To prepare the necessary documentation to be submitted to the responsible bodies in the attainment of material, funding, or consultative services for the betterment of the program.
5. That, without limiting the general activities of the Mutual Aid Area, the following projects receive priority:
 - (a) To implement a more effective and current area communications system.
 - (b) To develop and utilize Emergency Response Training Centres.
 - (c) To prepare and update the various resource manuals.
 - (d) To secure modern Emergency Response Unit(s) and Equipment.
 - (e) To develop and implement the Planning and Publicity projects.
6. That this agreement shall be continuous; however, any party to the agreement may withdraw from the agreement by giving each other party to the agreement sixty (60) days notice of such withdrawal.
